egistration is open for the 2013 Iowa Nonprofit Summit. This year the Summit will be held on Wednesday and Thursday, November 6 and 7 at the Meadows Events and Conference Center in Altoona.

Two highlights of the Summit will be keynote speaker Betty
Stallings on November 6 and the presentation of the Iowa Nonprofit Awards by Governor Terry
Branstad on November 7.

Betty Stallings, MSW, is a trainer, speaker, consultant and author. She has written seven books as well as numerous articles and training curricula, all in the areas of volunteer management, fundraising, leadership and board development. She is president of Building Better Skills, an organization that aims to inspire and empower people to use resources as effectively as possible in order

Ms. Stallings' talk, "Capturing the Potential Impact of Today's Volunteers: Leading the Way", will explore six crucial components that have an impact on your success. She will also present a breakout session on November 7.

Iowans Honored with 5000th Point of Light

to achieve their missions.

In 1989, President George H.W. Bush established the Daily Point of Light Award. The world's largest volunteer service organization, Points of Light recognizes persons whose volunteer efforts make a marked difference in the world.

On July 15, 2013, President Obama and former President George H.W. Bush were present at an event in Washington, D.C. honoring Floyd Hammer and Kathy Hamilton of Union, Iowa as the recipients of the 5,000th Daily Point of Light Award.

Motivated by the starvation they witnessed during an HIV/AIDS mission in

Tanzania in 2004, Hammer and Hamilton started Outreach, Inc. They initially focused on sending packaged meals to Tanzania and East Africa, but later broadened the scope of Outreach to help relieve hunger at home in the United States. To date, Outreach has provided more than 230 million meals to children in over a dozen foreign countries and domestically.

In addition to fighting hunger, Outreach is helping communities in East Africa with water systems, medical

The yearly presentation of the Iowa Nonprofit Awards will take place on November 7. Governor Branstad will make the presentations. The Principles and Practices (P&P) Institute will be presented again this year. Iowa Nonprofit Resource Center (INRC) Director Richard Koontz; Willard "Sandy" Boyd, INRC founder; and Jude West, also of the INRC will offer the P&P training in four sessions on Thursday, November 7. Those who complete the training on behalf of their nonprofit organizations may have their organizations listed on the INRC's Register of Accountability.

The Iowa Nonprofit Summit is made possible through collaboration with the Iowa Department of Management Grants Enterprise Management System (GEM\$), Iowa Commission on Volunteer Service, Iowa Council of Foundations (including Iowa Community Foundations), Larned A. Waterman Iowa Nonprofit Resource Center, Volunteer Centers of Iowa, and United Ways of Iowa.

training and equipment, and other sustainability projects. Hammer said, "For us, the old saying 'give a man a fish, and you feed him for a day; show him how to catch fish, and you feed him for a lifetime,' is a principle that guides us in all of our work from relief to development."

President Obama said of the couple, "If the purpose of this award is to celebrate Americans who work to make our country and world a better place—not for their own advantage or for any ulterior motive, but just to serve, pure and simple—I cannot think of anyone more deserving than Kathy Hamilton and Floyd Hammer. Today we can say that our country is a better place and a stronger force for good in the world…"

Michelle Nunn, CEO of Points of Light, spoke of the newest Daily Points of Light: "Kathy Hamilton and Floyd Hammer are inspiring examples of people who saw a problem and didn't hesitate to step up and try to solve it. Their work has done so much to create healthier and happier lives for children, and they are the walking definition of points of light."

FCC to Accept Low-power Radio Station Applications in October

The Federal Communications Commission (FCC) will accept applications from nonprofit organizations for low-power, FM radio stations from October 15-29.

This is the first time in ten years that local groups can apply for these station licenses.

The stations transmit less than ten miles in any direction but have the potential to reach an entire town or suburb. In large cities, one station could reach thousands of listeners. Thus these staions provide an affordable and manageable opportunity to bring locally relevant programming and information to communities.

The Greater Cedar Rapids Community Foundation

Grant program: Endowment Challenge Capacity Grant Fund

Grant description: Build sustainable funding for high performing nonprofits. Recipients must match gift within five years

of receipt.

Funding amounts: Up to \$25,000

Eligible grantees: Nonprofits in Linn County that have had the IRS determination letter for 501(c)(3) status for at least

seven years.

Grant application deadline: July 15

The Wellmark Foundation

Grant program: MATCH Grants (Matching Assets to Community Health)

Grant description: The overarching opportunity this MATCH funding offers is to create and resource healthy community demonstrations to evaluate the effects of a full complement of health-promoting policies and programs.

Funding amounts: Maximum of \$50,000

Grant description: Focus on projects in the areas of parks and recreation, education, and health.

Eligible grantees: Nonprofits primarily in Grinnell area.

Grant description: Focus on enriching the lives of children by supporting solid pre-K-12 educational programs.

Educating children is the cornerstone for building strong and enlightened communities.

Funding amounts: \$5,000 to \$10,000

Eligible grantees: Organizations must be designated as a 501(c)(3) organization by the IRS or be a governmental entity such as a public school district. Preference is for organizations that deliver effective programs, provide measurable outcomes and demonstrate financial stability.

Grant application deadline: Requests reviewed on ongoing basis.
